

**OUTDOOR LIGHT AGREEMENT**

This agreement is made and entered into on the date below by and between Dixie Electric Power Association, hereafter called "Association" and \_\_\_\_\_ hereafter referred to as "Member". The purpose of this agreement is to provide an orderly understanding of the installation of an outdoor light by the Association on the premises of the Member. This agreement also informs the Member that the light contains a photo-electric switch for turning the light on at night and turning it off at daylight.

***DIXIE ELECTRIC POWER ASSOCIATION AGREES TO DO THE FOLLOWING:***

1. The current used by the outdoor light will not be metered. The light will be maintained by the Association.
2. The term of this agreement shall be for \_\_\_\_\_ months from the date of installation of the light and thereafter until canceled by either party giving notice to the other.
3. The Association will bill the Member monthly for use of the above described outdoor light and the electricity consumed thereby on the basis of Rate Schedule SL and the Association's Service Rules and Regulations, plus state and/or Federal tax.
4. The same rules and regulations with reference to payment of Member's regular power bill will apply to payment of monthly bill for outdoor light.

***THE MEMBER AGREES TO DO THE FOLLOWING:***

1. The Member agrees to give employees of the Association the right of ingress and egress upon the property of the Member for the purpose of installing, operating, maintaining, or removing the said outdoor light described above.
2. The Member agrees to pay monthly \$\_\_\_\_\_, plus any additional cost of wholesale power subject to changes in Rate Schedule SL, plus applicable state and/or Federal tax.
3. The Member agrees to pay an additional \$1.10 per month for the first pole required, plus all construction charges as described in Section 208.10 of the Line Extension Policy, plus applicable state and/or Federal tax. If additional poles or a special type of pole is required, there will be additional charges.
4. The Member agrees that the same rules and regulations with reference to Association's collection policy on normal power bills shall be applicable.
5. The Member agrees to protect said light against abuse, such as throwing of rocks, use of rifles, or any means of destruction.
6. The Member agrees to report, within 48 hours, if the light fails to work properly. The Member's reporting that a light is not operating properly after 48 hours of discovery does not relieve the Member's obligation to pay for the month's lighting service.
